

**US Market Trading Promotion
1 July 2026 to 31 August 2026
Terms and Conditions**

1. The US Market Trading Promotion ("Promotion") is open only to clients who trade online with UOB Kay Hian Private Limited ("UOBKH").
2. This Promotion will run from 1 July 2026 to 31 August 2026 (both dates inclusive) ("Promotion Period").
3. The eligible account types are retail individual accounts and retail joint accounts.
4. Corporate/institutional, UOBKH Trading Representative accounts, and Staff accounts are not eligible for this Promotion.

6. Under this Promotion:

6.2 The eligible products only include Equities, Exchange Traded Funds (ETFs), Margin Trading, CFD Equities and Precious Metals.

6.3 Products that are not eligible include: Unit Trusts, CFD Indices, Endowus CPF Portfolios, Bonds, Equity Linked Notes, Wealth Management Products, and any other products not listed in clause 6.2 above.

6.4 The only eligible market under this promotion is the United States (US) Market.
